

Hunters Creek Pool Rules
Revised
15 April 2011

1. General

a) Access to the Recreation Facility is restricted to Hunter's Creek Recreation Facility members in good standing (A member in good standing is defined as a homeowner who pays the annual recreation facility fee and is a paid member of the Hunter's Creek Homeowners Association).

b). The Pool will normally be opened on Memorial Day weekend and closed on Labor Day weekend each year.

c). The tennis court will remain open throughout the year as weather permits.

d). The Recreation Facility Management Committee will determine specific hours of operation for the pool and tennis courts. General guidance is provided below.

1. The pool will open at 6:00 AM for adults only.

2. Family Swim from 10:00 AM to 10:00 PM.

3. Normal pool closure is at 10:00 PM daily. However, the pool will close at 7:00 PM when it is reserved for a private party.

4. Private Parties from 7:00 PM to 10:00 PM.

5. Pool and tennis courts will close at 10:00 PM.

e). The Recreation Facility Management Committee in coordination with the HOA board of directors may change the above general guidance).

2. Private Parties

a) The pool may be reserved for private parties from 7:00 PM to 10:00 PM daily.

b) Only Recreation Facility Members can rent the pool for private parties.

c) Private parties will be limited to 30 people.

d) A fee of \$100 will be charged to reserve the pool for a private party. (This fee is subject to change by the HOA in coordination with the Recreation Facility Management Committee).

e) A refundable deposit of \$50 will be held by the pool representative. Assuming the pool area is clean and in good condition, the deposit will be returned.

- f) Individuals renting the pool will sign a formal statement accepting responsibility for the conduct of their guests and for any damages incurred to the pool or property during the rental period or as a result of the party. Individuals renting the pool are also responsible for picking up trash and cleaning all areas used during the party and insuring their guests abide by the association rules.
 - a. Reservations for private parties will be made through the Chairman of the Recreation Facility Management Committee.
 - b. The pool will not be rented for a private party on the 4th of July.

3. Illinois Department of Public Health (Section 820.360 Patron Regulations) Rules and Instructions

Rules governing the use of the pool and instructions to patrons shall be displayed on placards provided by the Department, or equivalent, at the entrance to dressing rooms or the pool entrance and shall be enforced by the pool manager-operator. Such posting of rules and other instructions shall provide that:

- a) Admission to the pool shall be refused to all persons having any contagious disease, infectious conditions such as colds, fever, ringworm, foot infections, skin lesions, diarrhea, vomiting, inflamed eyes, ear discharges, or any other condition which has the appearance of being infectious. Persons with excessive sunburn, abrasions which have not healed, corn plasters, bunion pads, adhesive tape, rubber bandages, or other bandages of any kind shall also be refused admittance. A person under the influence of alcohol or exhibiting erratic behavior shall not be permitted in the pool area.
- b) The pool water is not suitable for drinking. Avoid swallowing pool water.
- c) Littering is prohibited. In addition, no food, drink, gum or tobacco is allowed in other than specially designated and controlled sections of the pool area. Glass containers are prohibited.
- d) All persons are encouraged to take a shower before entering the pool area.
- e) Personal conduct within the pool facility must be such that the safety of self and others is not jeopardized. No running, boisterous or rough play, except supervised water sports, is permitted.
- f) Only clean footwear, baby strollers, or wheelchairs are allowed in the pool area or bathhouse.
- g) Spitting, spouting of water, blowing the nose or otherwise introducing contaminants into the pool is not permitted.

- h) Glass, soap, or other material which might create hazardous conditions or interfere with efficient operation of the swimming pool shall not be permitted in the swimming pool or on the pool deck.
- i) All apparel worn in the pool shall be clean.
- j) All children who are not toilet-trained shall wear tightly fitting rubber or plastic pants.
- k) Diving in water less than five feet deep is not permitted except when allowed for competitive swimming and training.
- l) Caution shall be exercised in the use of diving facilities.
- m) Swimming is prohibited at outdoor swimming pools when thunder is heard or lightning is seen, including a 15-minute period after the last lightning or thunder is detected.
- n) If present, lifeguards are responsible for enforcing safety rules and responding to emergencies. Parents or guardians should supervise their children.
- o) No one should swim alone.
- p) The pool management has the authority to implement and enforce rules that are more stringent or that supplement those listed here.

4. Hunters Creek Homeowners Association Rules for Pool and Recreational Facilities

- a) **NO LIFEGUARD ON DUTY, SWIM AT YOUR OWN RISK.**
- b) Admission to the pool and use of the tennis courts is limited to Hunters Creek Residents and their guests. Guests wishing to use the pool and /or tennis court **must be in the company of their host/resident**, who is responsible for their behavior.
- c) Admission to the pool is limited to **resident pool members** in good standing. **Residents who are not pool members may not visit the pool or tennis courts as a guest.**
- d) Children under the age of 16 must be accompanied by an adult when using the pool.
- e) Horseplay, such as running, splashing, rough play, shoving or dunking, is not permitted. Only soft beach balls or toys are allowed to be thrown when the pool is not crowded.
- f) Admission to the pool will be refused to any person having a contagious disease, infectious condition, serious illness or related condition.
- g) Proper swimming apparel is required in the pool.

- h) Profanity, improper behavior and intoxication by facilities users is not permitted. Radios or audio devices are only permitted with the use of earphones. Excessive noise is not permitted.
- i) No dogs or other pets are permitted in the pool area or on the tennis courts.
- j) Smoking is permitted in designated areas only.
- k) Neither the homeowners association, pool management, nor the trustees assume responsibility for personal belongings lost or damaged in the pool area or on the tennis courts.
- l) State health code dictates that absolutely no food is allowed on the pool deck. Food is allowed in the pavilion area or at picnic tables in the outer deck area only.
- m) Please clean up any trash you may have or any trash found on the tennis court.
- n) No glass containers of any kind may be brought into the pool area.
- o) No trespassing after pool hours.
- p) Trespassers will be prosecuted, and violation of pool/tennis court rules may result in revocation of privileges and forfeiture of user fees.
- q) These rules may be changed or amended as approved by the Hunters Creek Homeowners Association board of directors.
